We assume no liability for any act, error, omission, injury, loss, delay, mishap, or damage to persons or property arising from any cause during the course of the Workshop or in transit thereto. We cannot accept responsibility for losses or additional expenses due to delay or changes in the services to be provided. We reserve the right to change our arrangements should conditions necessitate, or to cancel any aspect of the Workshop due to exceptional circumstances. This may include access to planned destinations or individuals.
- 2) In the event that we deem it necessary to cancel the Workshop we will provide a full refund, which the participant acknowledges as full and final settlement. Read the cancellation refund system outlined in Workshop descriptions.
